GRIVEGNEE – VERGER DE FAYENBOIS

Neighbours and future residents of the "Verger de Fayenbois" shall meet tonight for a first public space design and management meeting.

This meeting is organized by IMMOBEL and the City of Liège, in collaboration with the associations "Natagora" and "Façons de voir", which will assist them in order for the public areas to benefit from the opening of the new neighbourhood on its wider environment, including both the exceptional natural environment of the place and nearby neighbouring areas, while creating an identity and improving relationships between the residents.

This request for participation is exceptional, as is the programme which is currently under development.

Exceptional for its location, this project is located in the middle of an old orchard in Liège's Eastern area, between Jupille and Grivegnée, along Fayenbois' woods and the Ravel. The location has naturally led IMMOBEL to design a sustainable neighbourhood, in a green environment, attractive and modern, very close to the city and its facilities.

Also exceptional for its size, the project provides 151 apartments distributed in 115 lots for single-family houses and 36 apartments in two buildings over 16 hectares. This low density, in relation to the size of the land, makes it possible to develop qualitative public areas including a redevelopment of the orchard, as well as new meeting areas open to the public and connected by a large number of pedestrian ways, while providing a new access to the Fayenbois' woods to the neighbouring districts.

Following the starting of the construction programme in June, IMMOBEL is now pleased to announce and start commercialization of this beautiful project which, for some years now, was and remains subject of very many expressions of interest!
